- B. Additional Language regarding Lead Based Paints as provided by the Owners hazardous material testing agency: Commercial with end result as commercial: The general contractor will provide or ensure that any sub-consultant that will disturb areas with lead or lead based paint (LBP) provides, a competent person for the project that is competent in the Occupational Safety and Health Administration (OSHA) 29 Code of Federal Regulation (CFR) 1926.62 Lead in Construction Standard. This includes but is not limited to identifying lead and lead hazards, training workers on proper respirator and personal protective equipment (PPE) to be utilized based on exposure assessments compared to the Permissible Exposure Limit (PEL), ensuring lead safe work practices are used when working on components that contain lead and LBP, and providing proper hygiene facilities. For all requirements, refer to 29 CFR 1926.62.
- C. Loose and flaking paint shall be removed by methods permissible. To minimize dust and future peeling, the contractor may spot prime these areas after the loose materials are removed with Sherwin Williams PrimeRx Peel Bonding Primer or equivalent.

- A. Detail 2/A60 Clarification: concrete patch material shall be a site mixed Portland (approximately 4000 psi) and sand concrete mix with the latex bonding agent added/mixed in to improve its bond to the existing concrete. The existing concrete shall have the latex bonding adhesive applied to the surface of the existing prepared concrete in compliance with the manufacture's instructions prior to casting/pour/application of concrete repair.
- B. Contractor may utilize Ardex C_ type concrete repair materials at thin repair areas in conjunction with compatible bonding adhesives.


