Brief History

Public Works Warehouse Division received bids on September 12, 2014 at 1:00 P.M. for the purchase of a combination backhoe/front end loader. The backhoe/loader will be used for normal operations. Funds have been appropriated in the FY 14/15 Water Warehouse budget for the purchase of the backhoe-loader.

Analysis of Issue

Public Works Warehouse Division is adding this backhoe/loader to provide increased operational flexibility. The machine specified includes an extended hoe, which will allow excavation down to 15 feet. The machine will also come equipped with a pavement breaker. Currently the Street Division shares the existing backhoe (with extended hoe) and breaker with the Water Utility Division. Often, Public Works has multiple projects going at the same time and require the extended hoe and breaker. As a result, some projects get delayed due to competing demands. The new machine will go to the Water Utility Division and the older 2004 Cat backhoe (with extended hoe and breaker) will transfer to the Street Division.

Requests for bids were sent to three suppliers. All three responded. The bid quotes listed include all optional equipment and an extended warranty.
