**Brief History**

An opening for police lieutenant has occurred.

**Analysis of Issue**

On October 13<sup>th</sup> of 2014 a list of eligible's was certified by the Civil Service Commission and approved by City Council. Promotion lists carry a two year eligibility period. Since then, interviews have taken place to determine which candidate best met the needs of the police department to fill the vacant position.

Based upon the results of the previously mentioned actions, a candidate was selected. That candidate is Sergeant Cory Husske. Sergeant Husske began his career with the city of Fort Dodge in August of 2004. He was promoted to Sergeant in April of 2014.
