



# Parking Ticket Types Explained

## YELLOW HANDWRITTEN TICKETS

Used in situations requiring immediate attention, such as vehicles with over 24 parking violations.

## PRINTED TICKETS

Printed on durable, weatherproof paper, these are placed on vehicles and are used for situations needing immediate attention, including certain parking violations that require direct enforcement.

## AUTOMATED (MAILED) TICKETS

Sent directly to the vehicle's registered owner, these tickets are primarily reserved for downtown timed parking and permit violations that are less urgent; also utilized in situations when it's not safe or practical to exit vehicles to issue a ticket.
